

2016 Solar Senior Capital Ltd. Dividends and Distributions

Dividends and distributions that were reinvested through the Company's Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in the Dividend Reinvestment Plan should also refer to the above table.

Non-U.S. resident shareholders in a RIC are exempt from U.S. withholding tax on "interest-related" dividends and short-term capital gains dividends in accordance with IRC 871(k) and 881(e). For calendar 2016, 99.34% of each of the distributions shown above represent interest-related dividends and 0.0% of each of the distributions represent short-term capital gains dividends. To the extent that taxes were withheld on dividends distributed by the Company, this information may be considered in connection with any claims for refund of taxes with the U.S. Internal Revenue Service.
