

2021 SLR Investment Corp. Dividends and Distributions

The tax character of dividends and distributions from SLR Investment Corp. (the "Company") for calendar 2021 is set forth below. For tax purposes, the Company is a regulated investment company ("RIC") and designates the tax character of dividends and distributions you received for calendar 2021 in accordance with Subchapter M of the Internal Revenue Code of 1986, as amended.

0.32% of the dividends paid during calendar 2021 are eligible for treatment as Qualified Dividend Income and for the Corporate Dividends Received Deduction.

Dividends and distributions that were reinvested through the Company's Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in the Dividend Reinvestment Plan should also refer to the above table.

Non-U.S. resident shareholders in a RIC are exempt from U.S. withholding tax on both "interest-related" dividends and short-term capital gains dividends in accordance with IRC 871(k) and 881(e). For calendar 2021, 93.05% of each of the distributions shown above represent interest-related dividends and 0.0% of each of the distributions represent short-term capital gains dividends. To the extent that taxes were withheld on dividends distributed by the Company, this information may be considered in connection with any claims for refund of taxes with the U.S. Internal Revenue Service. Non-U.S. resident shareholders should contact their tax advisor with any questions regarding this information.
