Non-U.S. resident shareholders in a RIC are exempt from U.S. withholding tax on both "interestrelated" dividends and short-term capital gains dividends in accordance with IRC 871(k) and 881(e). For calendar 2015, 99.09% of each of the distributions shown above represent interestrelated dividends and 0.0% of each of the distributions represent short-term capital gains dividends. To the extent that taxes were withheld on dividends distributed by the Company, this information may be considered in connection with any claims for refund of taxes with the U.S. Internal Revenue Service.
